John Kivela Center

The John Kivela Center is a behavioral health campus where individuals can access all of their health care needs in one location. The facility is named in memory of John Kivela, a supporter of GLRC who served as a member of the Michigan House of Representatives.

GLRC Women's Services

Teal Lake Residential

Teal Lake Residential is a residential treatment program for women with substance use disorder offering clinically supervised withdrawal management, whole person care, individualized treatment plans including individual therapy and 40 hours of core and life skills group sessions. Mothers with children under the age of 11 are able to bring their children with them to Teal Lake Residential. Children over the age of 5 will have their own treatment plan. Onsite childcare is available while women are in sessions.

Sue B's House

Sue B's House is a recovery house for women that provides a safe and supportive, recovery-oriented environment for women who have achieved a minimum of 30 days in recovery. Women and their children up to age 11, may live at Sue B's House for up to one year.

Case management, counseling and community employment are all part of your stay at Sue B's House.

Medical Services

GLRC's medical services are staffed by a physician and nurse practitioners who provide both primary and specialty health care services for community members and current GLRC clients. Primary care services include family practice, routine physical, minor injury and illness, women's health issues and more. Specialty services include dermatology, Hepatitis C treatment, medication assisted treatment and ostomy care.

Outpatient Counseling

Licensed counselors offer individual and group counseling for community members and residential clients. Clinicians help to establish individualized goals for mental health and/or substance use disorders.

Child & Adolescent Services

Outpatient mental heath, psychiatric and substance use disorder services are available for children and adolescents at the John Kivela Center. Clinicians are trained in working with youth and are certified in a variety of evidence-based practices, to ensure the needs of each individual client are met. In addition to therapy, staff can also offer assessments, medication management, parent education, consultations and family therapy.

Veteran's Services

Veterans receive specialized counseling with a trained clinician and a veterans group is facilitated weekly.

Great Lakes Recovery Centers is licensed by the State of lichigan and accredited by CARF (Commission on Accreditation of Rehabilitation Facilities). GLRC is also HIPAA (Health Insurance Portability and Accountability Act) compliant. GLRC actively protects the confidentiality and privacy of their clients.



Other Services

GLRC offers a wide variety of behavioral health services across our locations. Other programs and services provided by the agency include:

Foster Care
