## **Recovery Housing**

#### **About Recovery Housing**

Recovery housing provides structure and support for those living in recovery and allows a safe environment for individuals to continue to heal from the impacts of addiction. Staff are committed to helping residents gain life skills, make healthy decisions, and strengthen their recovery. Residents attend group meetings, individual counseling, and weekly case management sessions. Often, after completing residential treatment for substance use disorders, clients return to the same living situation that had supported their addiction, and are faced with the same challenges and temptations they had before. While clients have changed during treatment, often times their living environment has not and that can present difficulties for continued success in their recovery journeyThis is why recovery housing can be an effective support program in the continuum of care for behavioral health services.

#### **Admission Criteria**

- 18 years of age or older
- Be able to live in a shared living environment
- Attend four self-help meetings weekly (NA, AA, SMART Recovery, etc.)
- Obtain full-time (32+hr/week) employment within 60 days
- Participate in weekly chores
- Attend weekly house meetings
- A minimum of 30 days in recovery prior to applying to Recovery Housing
- Service fees for the first month are due at the time of admission; alternative payment arrangements may be discussed.
